### **All dogs can earn ASCA Agility titles!**

As of January 1, 2003, ASCA requires registration of all non-ASCA registered dogs in order to record and track these dogs for ASCA titles. If you are not concerned about ASCA titles, you do not have to ASCA-register your dog to enter and compete in the trial. A form is attached to this flyer for your convenience.

Forms to register your non-ASCA registered dog (i.e., non-ASCA registered Aussie, breed other than Aussie or mixed breed) are also available at the ASCA web site, [www.asca.org](http://www.asca.org); click on "Forms" and look under General Forms.

## RULES OF AGILITY ENTRY FOR THIS TRIAL

Entries will be accepted on the basis of those received as postmarked for each day until the total of 350 runs per day is filled. On any given day that the trial would fill with the entries received for that day, the entries will be drawn at random to the point at which the trial is filled. If the trial is not able to accommodate all who wish to enter, a waiting list will be kept of those desiring to be on it in the order of postmark dates with random draw for the order within each date. Entries Close not later than 6:00 p.m. Thursday November 1, 2007, after which entries may not be accepted, cancelled or changed. Signature must be waived when using express or priority mail (Signature required items will not be accepted). No hand deliveries will be accepted.

## **CLUB RULES FOR THE TRIAL**

West Valley Dog Sports, Inc. reserves the right to refuse any entry. No entry shall be accepted from a dog or handler disqualified from the ASCA agility or all ASCA programs, or a person not in good standing with ASCA.

All dogs must be on leash when not competing in the ring. Please clean up after yourself and your dog.

Please take responsibility for your dogs and children. Any exhibitor whose dogs or children create unnecessary disturbances or engage in unsafe or disruptive behavior may be asked by the Trial Committee to leave the trial site.

No entry will be refunded if the trial cannot open or be completed by reason of riot, civil disobedience, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

There will be no refunds for entries withdrawn after the closing date, or in the event a dog and/or handler is dismissed from competition, regardless of the reason for such dismissal.

Refunds will be issued for bitches that come in season if notification in writing is received before November 5, 2007.

Checks not honored by the bank do not constitute a valid entry. There will be a \$25.00 service charge for returned checks.

Confirmations will be mailed or emailed to all entered with information regarding which classes you have entered and a date by which any corrections must be received by the trial secretary. Move-ups will be allowed at the trial from Saturday to Sunday if the request is submitted in writing by the end of the trial on Saturday.

Electronic timer will be used.

- 1.1 As used here: ASCA means Australian Shepherd Club of America, its affiliate clubs, and each of their members, officers, directors, employees, show chairs, show committees and agents.
- 1.2 Exhibitor/owner agrees to abide by the rules and regulations of ASCA, and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to, the condition of the grounds, lighting, security measures or lack thereof, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals, and people; exhibitor/owner assumes the risk of any harm arising for these.
- 1.5 Exhibitor/owner releases ASCA (including all officers, directors employees, and members), ASCSC and West Valley Dog Sports, Inc., (WVDS) including all officers, directors, members and organizing committee/s, and the officers, agents, and employees of the City of Los Angeles Department of Recreation and Parks, and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes responsibility for and agrees to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
